**FULL MEMBERSHIP ~ INITIATION FEE \$5,000 (waived until 02-28-12) / MONTHLY DUES \$310**

This membership category grants all rights, privileges and amenity use without restriction to include golf, tennis, pool, clubhouse, fitness center and other related amenities.

**TENNIS / SOCIAL / POOL MEMBERSHIP ~ INITIATION FEE \$3,000 (waived until 02-28-12) / MONTHLY DUES \$260**

This membership category grants all rights, privileges and amenity use to all club amenities with exception to golf privileges.

**HOUSE / DINING ~ INITIATION FEE \$2,000 (waived until 02-28-12) / MONTHLY DUES \$140**

This membership category shall be restricted to use of dining facilities only and shall include participation in all club social events.

**JUNIOR MEMBERSHIP ~ INITIATION FEE \$1,000 (waived until 02-28-12) / MONTHLY DUES \$190**

Membership applicants up to and including the age of thirty five (35) years of age shall be eligible for discounts stated above. Dues shall be the same as stated above for the membership category selected. Upon reaching thirty six (36) years of age, dues status will be elevated to Full Membership status. Dependent membership unconditionally terminates at 22. Prior to the age of 22, dependency qualification requires that the dependent lives at home with the parent(s), maintains full-time student status and is filed as a dependent for income tax purposes. The dependent junior may make application under this provision up to his/her 22<sup>nd</sup> birthday. The application, as with all membership categories, is subject to approval by the Board of Directors based on membership criteria.

**CORPORATE ~ INITIATION FEE \$10,000 (waived until 02-28-12) / MONTHLY DUES \$225 (3-corporate members minimum to qualify)**

The Club does make provision for a Corporate Membership category. This membership category is highly restrictive with concern to qualification criteria and the number of corporations accepted. The Club reserves the right to accept additional corporate memberships by invitation only.

**DEPRECIATION & OBSOLESCENCE FEE**

A Depreciation & Obsolescence Fee of \$250, in addition to monthly dues, shall apply to all membership categories. This fee will be an additional line item charge billed to each member's personal charge account in the months of December & June for the amount of \$125. This fee is dedicated to funding the costs associated with replacing worn/obsolete equipment and with the general maintenance and replacement of items critical to the long term health and viability of The CCSC.

**FOOD & BEVERAGE MINIMUM**

A monthly Food & Beverage Minimum charge of \$60, in addition to monthly dues, shall apply to all membership categories with exception to Honorary, Corporate, House / Dining and Junior Memberships. Certain Club functions may not apply to the minimum. Monthly food and beverage charges less than the required minimum shall create a charge for the difference between the required minimum and actual charges.

## **GENERAL POLICIES**

- a. The Board reserves the right to change membership fees and dues at its discretion.
- b. Completed application, payment of initiation fee, sponsorship letters and orientation shall be required prior to activation of membership.
- c. Membership is subject to the By-Laws, Rules & Regulations of the Club which may be amended from time to time at the discretion of the Board.
- d. The Country Club of South Carolina reserves the right to accept or reject any member applicant.
- e. The Country Club of South Carolina does not discriminate with regard to race, sex or religious affiliation in its employment practices or in its policies related to membership admittance.
- f. The By-Laws, Rules & Regulations of the Club shall be provided to each member upon approval for membership. Please refer to the By-Laws for specific rules, policies and regulations.

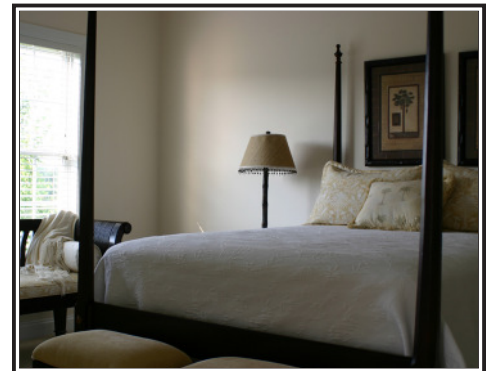
